INSTRUCTED RESOLUTIONS.

AMENDMENTS TO RULES.

RULE 5. CAMBERWELL BRANCH. "A member shall not belong to any other political organisation, or write or speak for any other political party except in opposition". CARRIED 24 - 16.

INSTRUCTED RESOLUTIONS.

MEMBERSHIP & ORGANISATION. (1)

WIMBORNE BRANCH. "That this Conference affirms that the Party's attitude to reforms and reformism is as laid down in the E.C.'s reply to the Provisional Committee in the 'W.B. of Upton Park' controversy of 1910. This Conference further affirms that the reply of the 1959 E.C. to Fulham branch on this question is an unsatisfactory and misleading statement of the Party's case in that it implies that the Party is opposed to reforms as such, and therefore calls upon the E.C. to prepare a fresh statement on the issue". CARRIED 25 - 13.

(2) FULHAM & CHELSEA BRANCH. "That this Conference censures the 1959 E.C. for their reply to Fulham & Chelsea branch on the reform question and accepts Comrade Lake's statement, in his circular to branches, as the Party's case on reforms." CARRIED 18 - 17.

(3) CAMBERWELL BRANCH. "That this Conference holds membership of the Armed Forces or Police to be incompatible with membership of the Party". CARRIED 19 - 16. *Party Poll?*

EDUCATION RESOLUTION.

(4) DARTFORD BRANCH AS ATTENDED BY LEWISHAM BRANCH. "That this Conference instructs the E.C. to investigate and report upon the possibility of weekend and summer schools". AMENDMENT & SUB - RES CARRIED 40 - 1.

(5) BLOOMSBURY BRANCH. "That this Conference instructs the E.C. to set up a special sub-committee to examine the Party Rules relating to electoral activity with a view to considering changes that may be advisable in the light of current conditions, and the Party's experience. The report to be presented this year". CARRIED 33 - 4.

(6) PADDINGTON BRANCH. "That this Conference instructs the E.C. to commence immediately investigations into the possibility of contesting one of the Nottingham Divisions at the next election." CARRIED 30 - 14.

(7) PADDINGTON BRANCH. "That this Conference instructs the E.C. to investigate the methods adopted by the Party in contesting elections". CARRIED 39 - 4.

FLOOR RESOLUTIONS

(1) MEMBERSHIP & ORGANISATION. Charge against Comrade R. Coster. RESOLUTION R. COOK. (Birmingham) & L. COX (Fulham & Chelsea) "That this Conference having heard the charge against Comrade R. We might have had to get rid of our H.O.Assistant, cheapened the S.S. and of course raised the dues. If we could increase our activity, we might increase our income. It might be worth while using our money to further the circulation of the S.S.

SUMMARISATION OF DELEGATES VIEWS.

It was thought that a statement of what was spent on H.O. should be in the statement of accounts. Also that H.O. and any other assets should also appear there. It was variously suggested that we should sell H.O. and move somewhere central, and at the same time use H.O. as fully as possible. Have a series of pamphlets. Let the shop portion of H.O. London today. Meetings are not run efficiently and branches are not in a position to appoint speakers, as they were in the past. The Propaganda committee are in a better position to do these things, and should be responsible for running all London outdoor meetings. Both members and the committee seem to be apathetic about meetings. It was said that times have changed, and good meeting places are far and few between, and that we should cultivate these. Members should not dissipate their efforts on the dead spots. We should seek other ways of putting our case over and selling our literature. The quality of our propaganda and our propagandists is said to have declined, and it was suggested that the fault lies with the Propaganda committee. They should see that our propaganda is co-ordinated and members supplied with information. Also that we must specialise our propaganda.

SUMMARISATION OF DELEGATES VIEWS.

It was said that members have not the knowledge that they should have. That our speakers are of poor quality. That there is a dull attitude in the Party. Nothing before or since Marx. That a series of theoretical lectures would help to fill a long felt want. The following resolution arose from this discussion.

SUMMARISATION OF DELEGATES VIEWS.

Members generally seemed to be of the opinion that the general layout of the S.S. was much better than it used to be. That special issues linked up with meetings and other events was a good thing. It was thought that we should make strenuous efforts to push the S.S. through Wholesalers, by guaranteeing their rate of profit. It was also thought that the general decline in the sales of the S.S. had been arrested by the improvements in the S.S. Other members disagreed with these views, being of the opinion that pictures etc., restrict the amount of written propaganda that can be put over. Special issues came under the same sort of criticism; that they tend to restrict the scope of the S.S. Other members were of the view that we should not overdo special issues, and only have them occasionally. One or two members seemed to be of the opinion that every issue of the S.S. was now a special issue. Three resolutions were moved from the floor arising from this discussion. They are as follows.

A letter had been sent by him to the E.C. but he had subsequently telephoned and asked the General Secretary to withdraw it. This the secretary had reluctantly done.

Hackney branch item for discussion No 11.

Summarisation of members views.

It was said that we are stagnating, and that we should do something about it. The fault we were told lies in the Party. We are too smug. We should take up a Marxist viewpoint on things of current interest like Africa, and the C.N.D. Some members seem to be of the opinion that the Party has a monopoly of all the ideas, and that we have nothing to learn. Others thought that we had more to say about current events than anyone else, and also that we should say it. It was thought that we are far too antagonistic in our approach to our audiences. We apparently take the hostility clauses literally in all fields. Some members thought that we should give support to the coloured movements in Africa. It was said that we should try to integrate not only our propaganda, but our branches. Propaganda should be planned on a long term basis. Tape recorded lectures should be sent round to the branches, and a library set up of them at H.O. It was also suggested that the decline in membership was to a large extent provincial.

1. CENTRAL ORGANISER'S REPORT.

The view was expressed that the Central Organise would have done better to report on his own activities, rather than on the shortcomings of others. The report was thought to be disappointing. Others thought the report was a good one, and that we should not discourage the C.O. by trying to limit his terms of reference.

RESOLUTION ISLINGTON BRANCH " That this conference expresses dissatisfaction with the Central Organiser's report and expresses the opinion that in future he should report on his own activities during the year under review."

RESOLUTION LOST 7 - 21.

EDUCATION. Items for discussion No.14. Camberwell branch & No.15. Paddington branch. In view of the lateness of the hour it was agreed to take the two items together.

It was thought that any talks, lectures, etc., on literature or any other subject should take place in the branch, and not at H.O. Members should not be forced to travel to Clapham. The E.C. should see that a series of talks goes on in the branches.
